The fund concentrates on the stocks of companies that are incorporated in China and that are listed as Ashares on the stock exchanges of Shanghai or Shenzhen. Sustainability aspects are taken into account by the fund management. A maximum of 20 % of the fund's assets may be invested in other stocks of companies that are incorporated in China or that generate a predominant portion of their profits there. The fund's investment objective is to attain capital growth over the long term.


