# **Investment Objective**



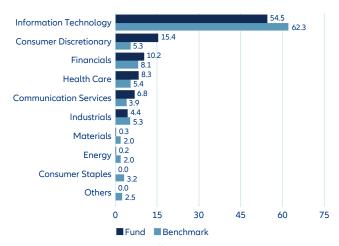


