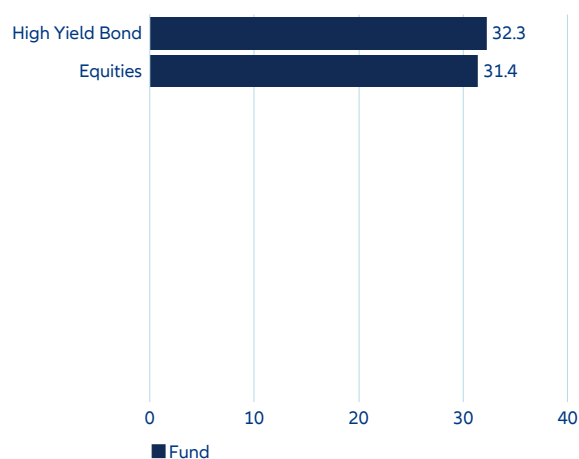

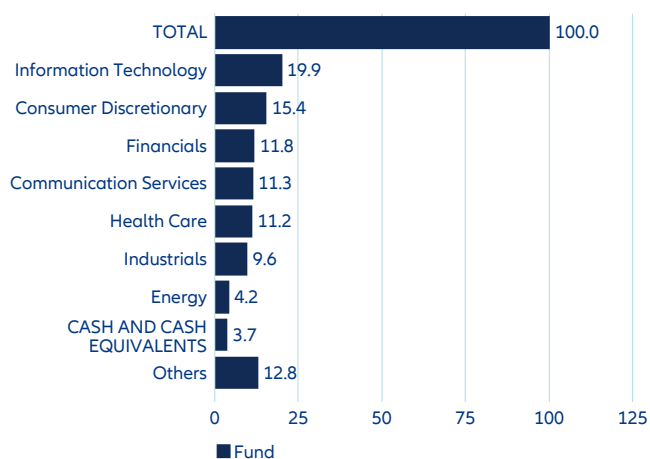

Equity weighting by sector (%)

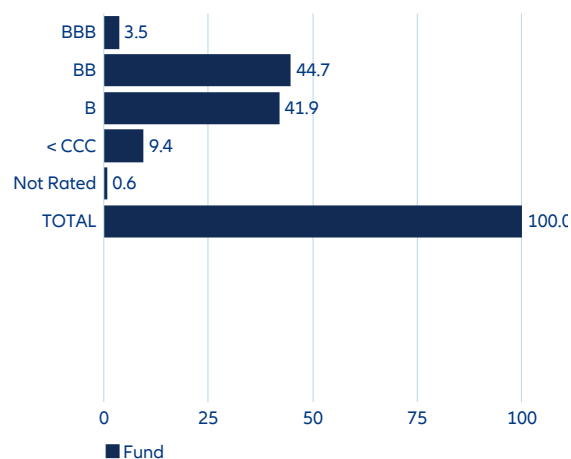
