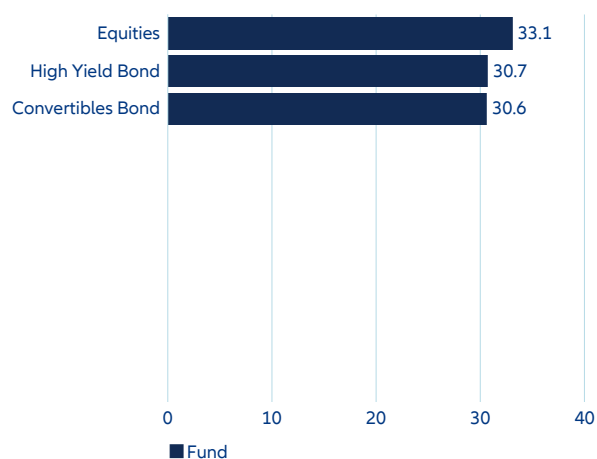

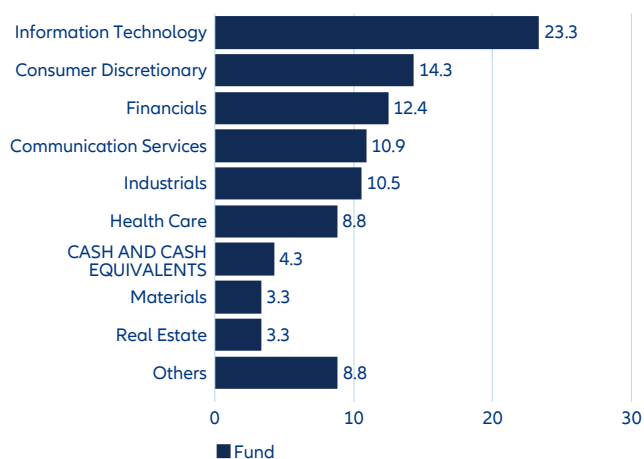
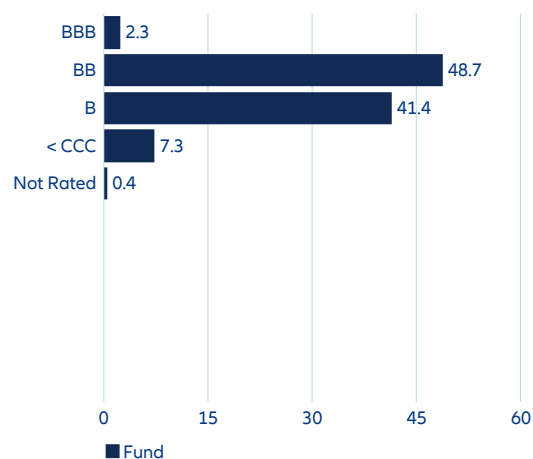
Portfolio Structure ⁶
