## Investment Objective

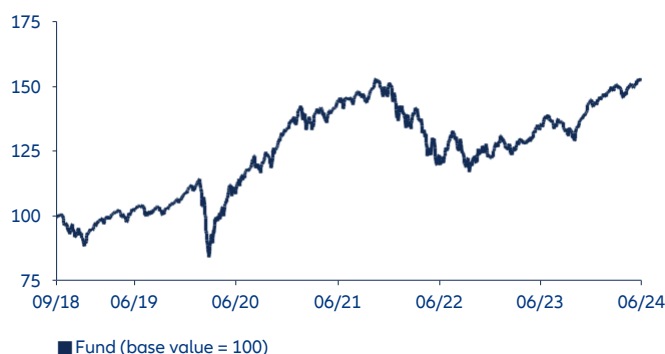

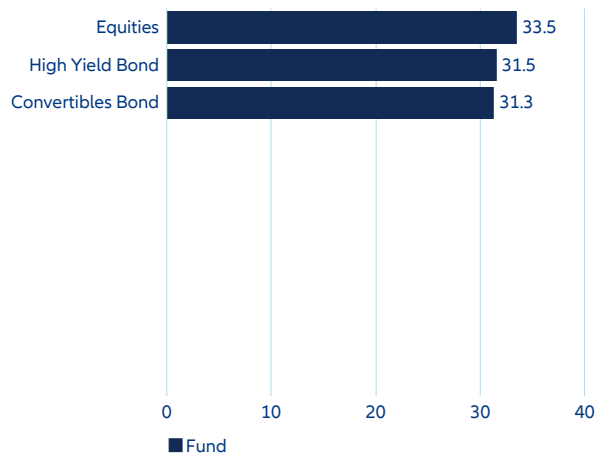

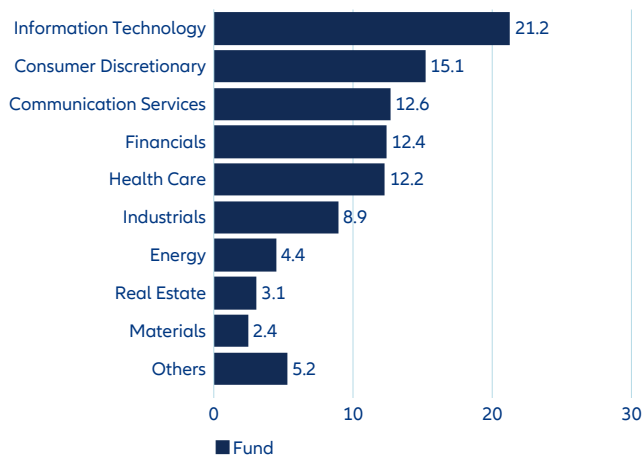
Asset Allocation Breakdown (%)



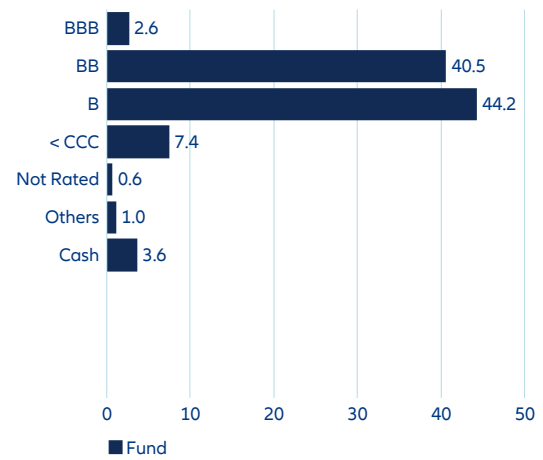
