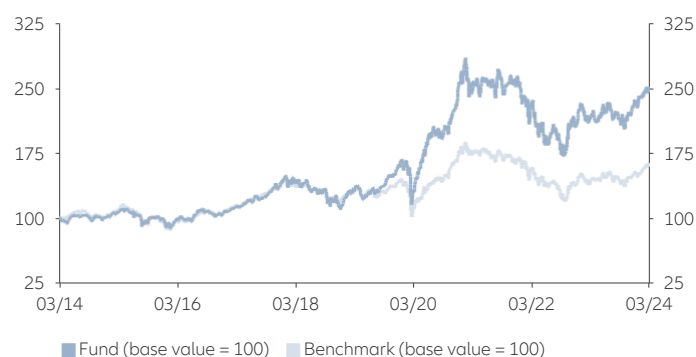

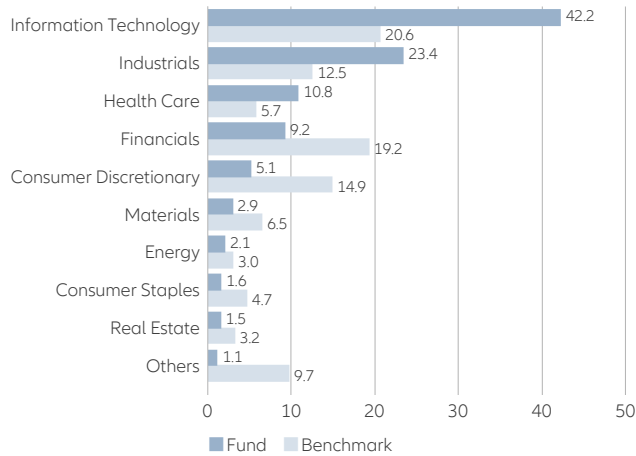

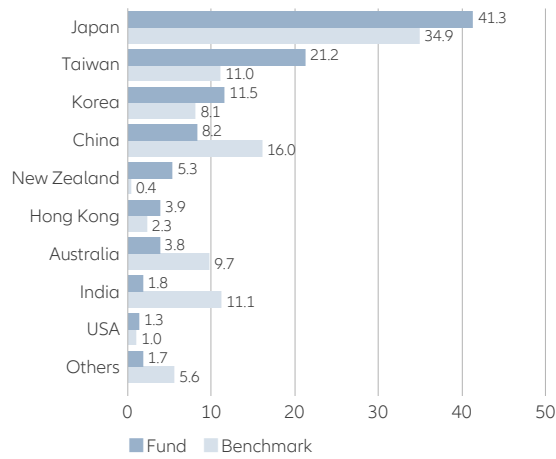
Sector Breakdown (%)



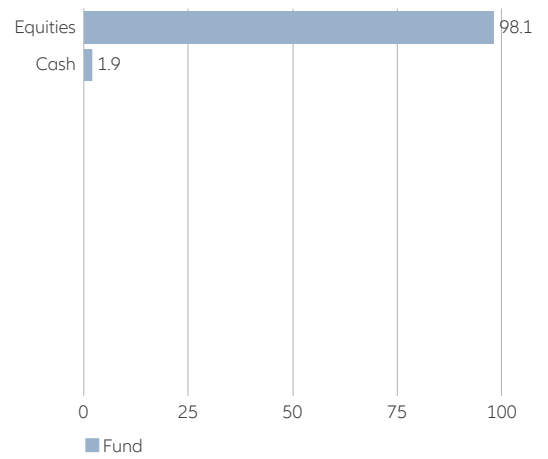
