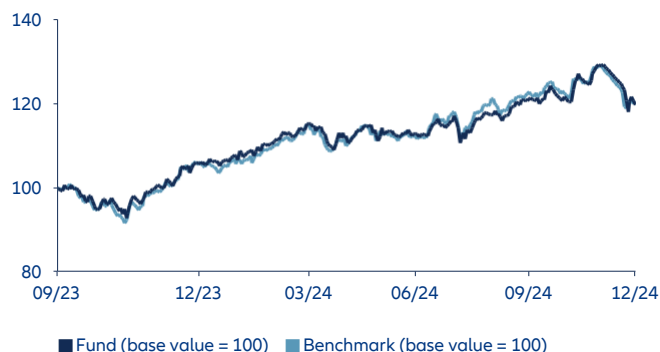
The fund invests primarily in the U.S. equity market focusing on value stocks. Its investment objective is to attain capital growth over the long term.

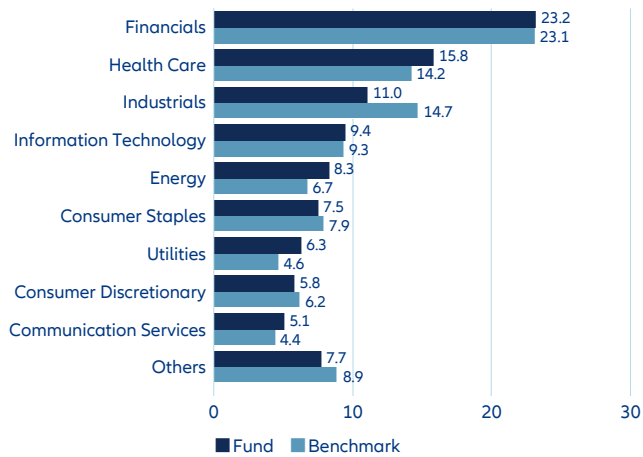

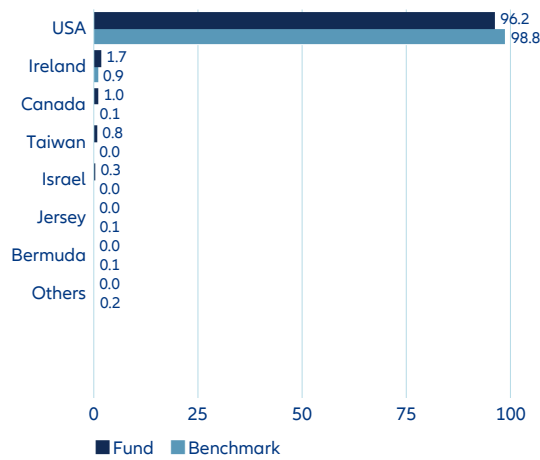
Sector Breakdown (%)
